### Subject: ASP Authorisation & Training Fees – process change v2

Dear ASPs,

Ausgrid has identified an improvement opportunity for the ASP Authorisation Management System (Pegasus). The aim of this change is to improve on the process for the payment of ASP Authorisation and training fees. This notice details the proposed change from the existing Sales Order requirements to a simpler payment system in Pegasus and changes in the training delivery system.

#### Current ASP authorisation fee process

The current ASP authorisation process requires a signed sales order document to be submitted by ASPs in the Pegasus system, this document details the ASP authorisation fee, and acceptance of the fee by the ASP. Submitted Sales Orders are reviewed by Ausgrid each month and then processed and invoiced directly to the ASPs.

This process requires ASP companies and workers to have a Sales Order document completed then uploaded in Pegasus annually, creating an administrative burden to the ASP. The process also causes a delay for Ausgrid to review and invoice ASP authorisation fees. The delay in issuing invoices can cause issues for ASPs in accounting and reconciliation of their costs.

#### Proposed ASP authorisation fee process

From 7 February 2022 ASP company and worker authorisation fees will be charged via the Pegasus system. The charges will be detailed and paid in the 'Subscription' section of Pegasus when initially registering or annually maintaining ASP authorisations. The Sales Order document will no longer be required from this date and therefore will no longer be a requirement to complete and upload in the Pegasus system.

This change will help reduce:

- ASPs administrative burden for the authorisation process; and
- provide simpler process for payment and invoicing of ASP authorisation costs.

**Note:** there is no change to the current ASP authorisation fees previously detailed in *GI11\_21 Ancillary Network Service Price Increase 1 July 2021* (link below).

#### Proposed Training Delivery changes

From 7 February 2022, ASP workers initial registration and annual renewal will include a training delivery fee, this will allow workers unlimited access Ausgrid's eLearning modules. You will be able to access and complete all assigned eLearning via Pegasus, including online Electrical Safety Rules modules, environmental training, NECF training etc. eLearn modules will be rolled out at go live and over the coming months.

**Note:** The process, and related fees, for booking face-to-face training remains unchanged.

## ASP worker registration cost changes

ASP Authorisation and Training costs for workers are detailed in the table below. ASP company authorisation fees remain unchanged and are not detailed here.

<b>Annual ASP Worker registration total</b>	<b>\$ 89.60</b>
